# Speakers' Corner


SPEAKERS'CORNER is a space set up within the fair for exhibitors who wish to present their project, product or service to the rest of the exhibitors and professional visitors.

#### 1. Booking:

Exhibition space is limited. Space reservation will be made in strict order of arrival of the forms.

### 2. Payment:

- •100% upon signing the contract.
- •All payments made to the Canary Islands Fair Institution are increased by 7% of IGIC.
- •INFECAR reserves the right to terminate the contract if the above payments are not made in accordance with the specified deadlines.
- •The amounts will be paid indicating in the entry document the name of the exhibitor that appears in the corresponding contract.:

### 3. Assembly and dismantling:

**Assembly**: November 20, 21, 22, 25 and 26 from 8:00 a.m. to 7:00 p.m.

Dismantling: December 2 and 3 from 8:00 a.m. to 2:00 p.m.

### 4. Parking spaces:

Exhibitors will be provided with one free parking space per stand.

#### 5. Accreditations and passes

Exhibitors will receive, free of charge, accreditations per hired space:

## Hired Space Accreditations:

Up to 27 m <sup>2</sup>	_
From 27 m <sup>2</sup> to 60 m <sup>2</sup>	3
More than 60 m <sup>2</sup> 8	2

Credentials must be worm visible at all times to access the exhibition site during assembly and disassembly, and during the exhibition days.

The credentials and passes may be picked up at the INFECAR offices, once the full payment has been made for the hired space.

### 6. Acceptance of the regulations

By registering, exhibitors automatically accept these rules of participation, they also undertake to respect the Technical Directives and Safety Provisions current in the Canary Islands Fair Institution.

### 7.. Non-compliance with the rules

INFECAR reserves the right to retain the goods displayed, and to take any action it deems appropriate under the contract, in the event of non-compliance with these rules of participation, or non-payment of any of the participation fees.

#### 8. Fortuitous event of force majeure

INFECAR may shorten, extend or postpone the event in case of force majeure, without exhibitors being entitled to claim any compensation for it.

### 9. International customs procedures

When registering, exhibitors of international origin they automatically accept the obligation to contact in your country of origin with the Chamber of Commerce to manage the "ATA Carnet" and thus process the temporary importation of goods. Failure to comply with this requirement or pay the amounts corresponding to this mandatory procedure, reserve to INFECAR to retain the displayed merchandise, as well as to undertake the actions that it deems appropriate according to the contract.
